1. Update on camera, litter link to Police, Tiverton, and Litter Websites (Capt. Jones)  
**Natalie will contact Capt. Jones for follow up to the above items.**

**Nothing to report as of this meeting.**
3. Eagleville Trash barrels/bin (Eagleville Litter Patrol) (Vicki)  
**Natalie will ask Capt. Jones if he found out who removed the trash from Eagleville Road and who placed the two trash barrels along Eagleville Road this past spring.**
4. Park and Ride (Vicki)  
**Vicki will check in with the Boy Scouts (Troop #4218) in late September—when the troop regroups for the new academic year—to ask if they plan schedule a clean-up day at the Park and Ride as the Boy Scouts adopted this area of town and it needs attention.**
5. Litter Committee--a stand-alone committee (forms?) (Natalie)
