TOPICS: COMMITTEE TASKS

1. Update on camera, litter link to Police, Tiverton, and Litter Websites (Natalie/Capt. Jones)
Capt. Jones is pursuing the possibility of purchasing cameras with a new salesperson. Capt. Jones wants permission to link the Police Facebook page to the Litter Website. Permission was granted by the committee members.
2. Twin River Casino (updates) (Maureen M.)
The casino subcommittee noted on the casino Web site that litter in the area of the roundabout will be in the HSA (Host Community Agreement). Attorney Russo believes that litter in the area of the roundabout and the entrance of the casino would be in the operational agreement.
3. Park and Ride (Vicki)
Vicki has not heard back from Jeremy, the Boy Scout troop Leader, about plans to clean up litter at the Park and Ride. She e-mailed him last month and will follow up.
4. Litter Committee as a stand-alone committee (Committee)
